#### FROM THE PODIUM

Well here in the Land of Lincoln spring has sprung. Our boys of summer have taken the field with the usual optimism, and visions of a cross town World Series dances in our heads or maybe the new Bears will win the Super bowl! It is so much easier to contemplate these highly unlikely events than to solve our real problems.

We can read daily about the dire straits our state's finances are in, as well as our county and local taxes increasing. Meanwhile, our politicians are more concerned with maintaining their own positions than actually solve problems.

I am not advocating that our public workers, teachers, police, fire, or municipal should lose *defined benefit pensions* or access to health plans, but I do question **who** is eligible to participate in these benefits. I am unable to fathom how **part time board members or paid lobbyists** can accrue these benefits.

I am also appalled that administrators get their salaries jacked up only to increase pensions they receive and then go on to other highly paid positions within the State. This happens constantly, sometimes into custom made positions in the same town. There are also the *automatic* colas that are received whether or not there has been any inflation, as we know from the lack of social security increases for two years.

I understand that these benefits have been negotiated and that the State has failed to meet its obligations. I also realize that most do not participate in social security and they "pay" into the plans themselves, just as **we paid** into social security, we also paid into our own pensions thru a negotiated contract.

Both parties are complicit in this problem so don't blame one side or the other. They have all failed to meet the basic fiduciary responsibility to the participants as well as us, the employer. Unless we demand a change in our politician's approach **all** of us will suffer.

#### April 11<sup>th</sup> 2012 Speaker

Our speaker was Commissioner Frank Avila of the Metropolitan Water Reclamation District of Greater Chicago. Being one of the biggest the District is visited by people from all over the world to see how it cleans up the water. Residue collected after cleansing is given to farmers for fertilizer. It is ranked as Class A Bio-solid.

He spoke of the deep tunnel and how it prevents flooding. It's 109 miles long and serves the city of Chicago and 24 local communities. One inch of rainfall can amount to 50 billion gallons of water. When the locks are opened during bad rains the waste water overflow is sent to the lake. The closing of the beaches was blamed on this action, but it was determined That E. Coli responsible for the beach closures came from sea gulls. Their eggs are painted with a chemical to lower sea gull population.

He warned that new born infants are contracting adult diseases because of soaps and other personal care products that contain chemicals banned all over the world but not here. The compound he found to be of emergency concern was triclosans. Pesticides and herbicides also are affecting our children. Our water is some of the best but prescription drugs should be turned in for proper disposal and not flushed down the drain.

Frank was an interesting and entertaining speaker. He was elected to this position in November of 2002 and is the only engineer on the nine member board and brings a blend of experience and expertise to the board. We want to thank the District and Frank for speaking to us today.

#### RECIPE EXCHANGE

I am not a salmon lover but Al enjoys it every so often. I found these recipes and now I cook salmon for both of us.

#### GRILLED SALMON WITH TARRAGON

Take 2 salmon pieces about 5 ounces each, and sprinkle dried tarragon on both sides of the fish, pressing or rubbing gently to make sure it sticks. Lightly coat each piece with about 1 tablespoon of light mayonnaise, being careful not to remove the tarragon.

Oil your grill if using a charcoal grill. electric grill, or baking dish. Allow 10 minutes of cooking time for charcoal grill and 5 minutes for electric grill. I bake mine in a preheated 400 degree oven for 10-15 minutes. Salmon should be firm yet moist. If you overcook it will become dry and tough.

You can use tarragon sauce to spoon over, if you like. **Tarragon sauce is:** 

2 tbsp. plain low-fat yogurt

2 tbsp. light mayonnaise

1 ½ tsp. dried tarragon

½ tsp. Dijon mustard.

Mix well and refrigerate until ready to serve.

#### SALMON WITH DIJON SAUCE

4 - 6oz salmon fillets

½ cup Dijon mustard

3 tbsp. olive oil

3 tbsp. lemon juice

1 tsp minced garlic

Season salmon with salt and pepper and place into greased baking dish. Mix remaining ingredients reserving  $\frac{1}{2}$  cup sauce. Spread remaining sauce over salmon and bake in preheated oven at 400degrees for 10-15 minutes. Serve with reserved mustard sauce.

# Remembering Memorial Day

### An American Oligarchy Defined

At a time when the middle class is collapsing and poverty is increasing and the wealthiest people are doing phenomenally well, many Americans are wondering whether this country is moving toward an oligarchic form of government where a handful of very wealthy people control the economic and political life of the nation. At a time when the richest 400 Americans own more wealth than the bottom 150 million people, it was not surprising to learn from a recent study that between 2009 and 2010, 93 percent of all new income went to the top 1 percent of U.S. taxpayers. Additionally, it is extremely disturbing that because of the absurd Citizens United Supreme Court decision, many of these billionaires are now using their money to strengthen their political hold on the country. "This is not what democracy looks like. This is what oligarchy and plutocracy look like.

#### NO BAILOUT NEEDED

On Monday April 23<sup>rd</sup> 2012 the Social Security Trustees released their annual report on the financial status of Social Security. The report, issued every year, projects Social Security's income and outgo for the next 75 years. Once again, this year shows that Social Security has a large and growing surplus.

Last year's report projected that at the end of 2011, Social Security would have a surplus of about \$2.7 trillion, which it now has. This year's report predicts the surplus will remain at about \$2.7 trillion at the end of 2012.

The 2012 report projects that Social Security can payout benefits in full through 2033. After that, Social Security can payout three-fourths of the benefits earned.

All that is needed to keep Social Security strong is a simple adjustment - have everyone pay their fair share. Today, people earning \$50,000 per year contribute 6.2% to Social Security. People making \$500,000 per year only pay about 1%. If the Social Security tax cap were raised or eliminated Social Security would remain strong for years to come.

The Social Security Trustees Report shows that our Social Security system works just as intended, even in difficult economic times. Unlike the banks, which nearly brought the economy to ruin, Social Security didn't need a bailout.
