### RECIPE

Lamb Chops Korabiak
1/4 cup butter
6 to 10 mushrooms, sliced
2 to 3 green onions, sliced
2 large or 4 small lamb chops
1 teaspoon of minced rosemary
Salt and freshly ground pepper
Garlic powder
1 cup of red wine

Melt half of butter in a large skillet over medium-high heat. Add mushrooms and onions and sauté until tender (5 to 10 minutes). Remove and keep warm. Melt remaining butter in the same skillet over medium-high heat.

Sprinkle chops with rosemary, salt, pepper and garlic powder. Add to skillet and sauté until browned on both sides (about 5 minutes).

Reduce heat to medium and continue cooking until tender.

Transfer lamb chops to a heated platter. Pour wine into the skillet and cook over a medium-high heat, scraping up any browned bits on the bottom of the pan until liquid is reduced by a ½.

Spoon vegetables over chops and top with sauce. Hmm!


